
Beng Kuang Marine's revenue increase by 22% to S\$42.7 million in 2Q2009

- New contracts secured in CP division and on-going projects in IE division helped propel BKM's revenue
- Net profit attributable to equity holders of the company sustained at S\$3.0 million in 2Q2009

Singapore, 7 August 2009 – Beng Kuang Marine Limited ("BKM", "the Group" or "明光海事"), an established provider of Infrastructure Engineering ("IE") services, Corrosion Prevention ("CP") services and Supply and Distribution ("SD") of hardware equipment and tools to the marine and offshore oil and gas industries, is pleased to announce a 22% growth in revenue to S\$42.7 million in 2Q2009 during the current uncertain economic climate.

With higher revenue recognized from on-going construction and pipe fabrication projects in BKM's Batam yard, revenue from the IE division grew by 69% to S\$17.3 million in 2Q2009. The

CP division also managed to clinch new projects during the quarter, including the S\$9.0 million

new offshore contracts as announced on 20 April 2009. These have led to better performance in

2Q2009.

To better weather the downturn in the SD business, the Group took cautious steps to reduce

selling and distribution expenses which resulted in a reduction of 34% to S\$0.5 million in

2Q2009.

Overall, the Group's profit before tax grew 18% to \$\$4.5 million, while profit attributable to

equity holders of the company sustained at S\$3.0 million in 2Q2009.

The outlook for the marine oil and gas industries remains uncertain.

"2Q2009 has been fruitful for BKM as we have been able to grow our revenue despite the

current uncertain economic climate. We have also successfully completed the load out

of our first 260-men deckhouse accommodation block onto a new pipe laying barge.

BKM will continue to manage its costs prudently while seeking opportunities to secure

more marine and offshore oil & gas contracts for the new fabrication yard in Batam."
